SLANDER and LIBEL

In an e-mail I sent to Jack Zimmermann, exactly five years ago on this date I made this very TRUE statement, that has been fully and completely documented as being absolutely true.

“For a number of years we have been treated as if we were Jews in Nazi Germany in 1938.”

From 1933 until KRISTALLNACHT in November of 1938, German Jews were only harassed and mistreated just as my wife and I have been harassed and mistreated by Zimmermann and WIA since at least 2004.

ZIMMERMANN’S SLANDEROUS AND LIBELOUS
WRITTEN STATEMENTS he sent to:

JOHN CHARLTON: Charlton stalked and harassed our property manager, Mike Zeltner and has been absolutely mean spirited toward me although I have always smiled and waved and slowed down for his dog yet the hate on his face is horrible.

TRAVIS KITCHENS: One of the most unethical and dishonest lawyers that I have ever known. He and Zimmermann spent years plotting against our Church our Foundation and my wife and me costing us a huge fortune in attempts to defend ourselves.

BOB LANE: Lane and a gang of drunks stationed their pontoon boat in front of our house and harassed us and our animals with cursing and spotlights that lit up the entire house.

JUSTIN CURREN: I tried several times to befriend Justin Curren but he never reciprocated. I complimented him on his home and garden and invited to give him a tour of our botanical preserves but he was not interested.

THOMAS READAL: Now this guy is a “work of art”. WIA has always been hateful and opposed to our prescribed fires to reduce fuel loads in our forests to protect Waterwood from wildfires. Readal would call the TCEQ and press formal “charges” against me. He even wrote a bizarre notarized affidavit in which he complained to the TCEQ that one of our fires targeted his hermetically sealed \$729,000 house and made him sick. I quizzed other folks on the street and no one else suffered from any smoke inhalation. The fire was well over a mile away from his house.

RICK BROWN: WIA Board Member during which time we have been continuously harassed.

MIKE BERCU: WIA Board Member during which time we have been continuously harassed.

SANDY SINGLETARY: Definitely an “insider” and “team player”

ROBERT BECKLES: WIA Board Member during which time we have been continuously harassed.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 1

Zimmermann called my e-mails of 10 June 2016 “offensive and bigoted”.

There is NOT one offensive or bigoted word in either e-mail.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 2

Zimmermann said that I “...did not possess the normal use of his mental or physical facilities when they were written.”

So Zimmermann tells people that I am mentally and physically defective? What is the evidence Zimmermann? I am not a pathological liar and I live up to all of my commitments as an ETHICIAN.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 3

Zimmermann says that I am “severely prejudiced against minorities”.

I lived in the hood in Baton Rouge in 1966-1967 and marched for Civil Rights which was very dangerous for a white boy in Louisiana at the time.

We lived with the Black Caribs in Toledo District, British Honduras in 1968.

Our first grandson is a mixture of African, East Indian and Anglo American DNA.

We established a MUSEUM OF GENOCIDE and ATROCITIES with photos of evil Nazis in our “Rogues Gallery”.

We produced two educational films:

THE HOLOCAUST: A HISTORY and ANNE FRANK and THE HOLOCAUST, used to educate school children about the horrors experienced by European Jews during World War II.

We also expose the evils perpetrated against victims of Genocide in all parts of the world and especially against Native Americans.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 4

Zimmermann then calls me "...a racial, ethnic, and religious bigot."

Show any proof at all Zimmermann. How can my Church which you and WIA have harassed, threatened, sued, cheated us out of millions of dollars by convincing us that if we sold the parkway at \$4 million less than its actual value, there would be perpetual peace between WIA, our Church, our Foundation and ourselves.

Our Church has Jewish members, Jews in our cemeteries, and our Chapel of the Nativity includes a famous Jewish family and is open 24/7/365 to any and all persons regardless of race, religion, sexual preferences or any other ethical way of behaving.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 5

Zimmermann claims that I compared "WIA to the Nazis in Germany."

That was a TRUE STATEMENT in that the Nazis did not begin the "Holocaust" until the 1940's, so in 1938 WIA was treating us worse than the average German Jew had been treated.

During Kristallnacht, it is believed that fewer than 100 Jews were killed, which is way fewer than the Black citizens in Oklahoma

were treated in 1921. Of course Kristallnacht was EVIL and started the serious hate campaign against the remaining Jews in Germany at the end of `1938.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 6

Zimmermann falsely claims that I am comparing myself to “the poor plight (of) the poor souls who suffered Nazi atrocities is ludicrous.”

Once again Zimmermann exposes his TOTAL IGNORANCE of the discrimination against German Jews BEFORE the beginning of the Holocaust.

I do not know of any “atrocities” before November of 1938, but there have been many crimes, thefts and vandalisms perpetrated against me, our Church and our Foundation between 2004 and the present time, or 17 years of having to deal with hate crimes against our Church and against me including multiple shootings, multiple assaults, multiple hostage takings, multiple false arrests, multiple frivolous lawsuits meant to destroy us, our Church and Foundation financially, multiple acts of criminal trespass and criminal vandalism on God’s Garden Parkway and other Church and Foundation properties, plus being shunned and not allowed to participate in community activities including being threatened with arrest for even entering the WIA building to observe a card game and so on and on and on.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 7

Zimmermann falsely states that I “defame and minimalize the Jewish victims of the Nazi regime.”

Another Zimmermann bald-faced lie to stir up more hatred against us, by spreading this lie throughout the community.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 8

Zimmermann really endangers my health and welfare by falsely stating that I have “a serious ANTI-SEMITIC character.”

Nowhere in either of the June 10th 2016 e-mails Zimmermann refers to in order to concoct and fabricate a spurious, dishonest and hateful DEFAMATION OF MY CHARACTER, indicates any form of anti-semitism.

In actual fact I have promoted CONVIVENCIA for many years, which refers to peaceful co-existence between Jews, Christians and Muslims.

We have established a CHILDREN’S MUSEUM OF WORLD PEACE which will house an “altar” that displays each of the world’s major religions and promote peace between all religious.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 8

Zimmermann further defames me with further character assassination with the false statement: “Your claim that you have suffered at the hands of WIA as the Jews did at the hands of the Nazis is preposterous...”

Actually in studying how Jews were treated in Nazi Germany from 1933 until November of 1938, in many ways we have been treated far worse.

Our church properties have been repeatedly vandalized in CONTEMPT OF COURT. Our Chapel of the Nativity has had its

“glass” shattered in an attempt to steal Baby Jesus, who incidentally was Jewish as well as his parents, shepherds and others with the exception of the Zoroastrian “Three Wise Men”.

Hundreds of thousands of blooming wildflowers were destroyed on God’s Garden Parkway, the day after we buried our murdered daughter.

Three security cameras belonging to our church has been stolen and the sheriff refuses to even order the KNOWN thieves to give the cameras back.

Bells, benches, life size animal statues have been stolen from our Church properties and our Church owned Veterans Cemetery has been trespassed upon by poachers and vandals. WIA contractors even chain-sawed down an extremely rare old growth Longleaf Pine in our Veterans Cemetery.

There have been two arson events on our Chapel of the Nativity property, and numerous other arson events after our controlled burns were out. Mysterious fires would break out nearby but not in any way related to our controlled fires yet we would be blamed.

The current Fire Chief, who does NOT live in Waterwood, joined forces with WIA in order to concoct bogus reasons for damaging or vandalizing our trees in CONTEMPT OF COURT and also refused to allow us to post our annual burning notice and then intimidated me by telling me that the Texas Forest Service and TCEQ does NOT want us to burn.

Zimmermann twice ordered Waterwood Security to disregard any crimes committed on our Church and other properties and when I was assaulted, held hostage, and my cell phone stolen with the evidence of the crimes, Bo Hayman became a witness to the

crimes. I had known Bo for over 50 years and when I asked him to tell the Sheriff Deputy who arrived what he had witnessed, he refused to say anything, later telling me that he would be fired if he said anything about the crimes that he had observed.

When Baldomar Garcia was a WIA security guard he was ordered to NOT witness any crimes against us or our Church, Kristi Zeltner, our property manager asked him what he would do if he saw her being raped. Garcia said, "I would knock the guy off and finish the job."

The day we left for Disneyland for the World Premier of my movie: LONG PIG, Garcia was ordered to go down my parent's private drive and harass them with false complaints about their home while Zimmermann's home had trees growing out of the gutters.

Zimmermann promised that our Veterans Cemetery sign was grandfathered he lied and forced us to move the sign back 200 feet from the road and we were told that the man with the rifle who was guarding the wounded soldier was the man that shot the soldier.

Then our Church had more horrendous legal expenses and had to pay for a new sign that WIA eventually approved of.

Now WIA refuses to allow our Church to erect any signs at all after we had a beautiful one constructed that quoted Jesus. It along with our Frogjoy Woods sign are in storage as WIA refuses to allow us to erect any signs at all in CONTEMPT OF COURT.

Speaking of CONTEMPT OF COURT, Zimmermann issued what I believe constitutes a TERRORISTIC THREAT against me, a Senior Citizen and BISHOP, by conspiring with a corrupt District Judge to throw me in jail for 124 years and force our Church to pay

a fine of \$103,500 for legally, and in accordance with State Law placing purple paint stripes on our trees on Church and Foundation properties that are NOT on HOA properties.

In order to NOT go to jail I had to agree to allow Zimmermann dba WIA to extort and defraud our Church out of a significant sum of money and also allow WIA to vandalize our trees with the purple paint with a high speed grinding machine.

In studying the treatment of Jews in Nazi Germany from 1933 until November 9, 1938, I have found no evidence that German Jews were treated any worse than we have been treated under Zimmermann's hate regime against me and our Church and against our Church owned Veterans Cemetery.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 9

Zimmermann then goes on to defame me by writing and distributing his "hate letter" to others, that my "anti-semitism is FLAGRANT."

There has never been a hint of anti-semitism during my entire 76 years of life on this planet. Just because Zimmermann has NEVER given me any reason to trust him and thus I believe him to be ethically bankrupt based on years of abuse by WIA under his direction as President of the HOA, does NOT mean that I am anti-semitic. It just means that there is one and now two Jews in the form of the new WIA attorney Katine, that I have zero respect for in that they both chronically thumb their noses at the Texas Bar Code of Ethics.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 10

So now Zimmermann states that my alleged FLAGRANT anti-semitism is “not a new posture for (me)”, by falsely accusing me of calling my “neighbors” “INBREEDS”.

This is just one more flagrant display of Zimmermann’s ignorance. Perhaps if he would read my wife’s favorite book: CRACKER CULTURE he would understand what I meant as an ANTHROPOLOGIST: By their flagrant hatred of natural beauty, hatred of wildlife, hatred of Waterwood’s Protective Covenants which WIA has eviscerated, love of cancer causing chemicals, hatred of wildflowers and the 130+ species of native Texas plants that were growing on GOD’S GARDEN PARKWAY, WIA Board Members and their entourage of family and friends have consistently displayed “redneck East Texas white trash” values.

Zimmermann of course, misapplied the word “inbreeds” to the actual DNA of the persons referenced. Anthropologically speaking the cultural traits that reflect redneck white trash values have changed very little in well over 100 years in East Texas.

So in spite of educational opportunities over the course of 100+ years or over several generations the redneck white trash values have changed very little and thus the “values” are inbred.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 11

Now Zimmermann writes that I call people I don’t like “the Mexican” “the Puerto Rican,” “the sand niggers”.

Hello!!! What kind of proof does he have? When Garcia became one of my best friends after he left the control of WIA, he referred to himself as “the Mexican”. There is nothing wrong with a person of Mexican heritage calling himself “the Mexican”, unless Zimmermann thinks that somehow being a Mexican in origin and

proud of it is somehow meaning that Zimmermann believes Mexicans to be dirty, drug dealers, rapists and criminals in general as right-wingers like to categorize them.

I don't know who "the Puerto Rican" might be other than one of my best friends, Tito Estrada, who is a member of our Church and my wife's chauffeur, Michael Ojai. We have traveled all over Puerto Rico more than once and we love the island and its people. Once again Zimmermann's nonsense smacks of hatred of Puerto Ricans.

I have no idea who he is referring to in regard to the term "sand niggers". Until recently there has been no one from India or the Middle East living in Waterwood and the Jordanian who is building a log house near the Villas is very nice and I have loaned him one of our workers to help him from time to time.

It thus seems that Zimmerman is displaying his prejudices and then is unethically making his audience think that I am the prejudiced person, when in fact it is the Texans that have brought misery to our lives since 2004 that have been my adversaries.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 12

Then Zimmermann writes that I use "other terms that demonstrate (my) prejudiced view of those who do not accede to (my) bullying.

This statement by Zimmermann is absurd on face as my wife and I have been the victims of constant bullying by WIA and WIA associates, of course with Zimmermann at the head of the gang for many years during which we have been constantly bullied under his "leadership".

I am a pacifist. I have never shot at anyone in Waterwood, or held anyone hostage, or vandalized anyone's Church or other properties, or stolen from anyone, or assaulted anyone or done to anyone in Waterwood the same way we have been bullied and terrorized.

SLANDEROUS AND LIBELOUS STATEMENT NUMBER 13

Zimmermann states that while I am "bullying" I "throw around my money."

That is an insane statement on face as Zimmermann and WIA's frivolous lawsuits, and attempts at bankrupting us including fraud and extortion by WIA, has forced our Church, our Foundation and ourselves to expend hundreds of thousands of dollars in attempting, so far without success, of PROTECTING OUR FIRST AMENDMENT RIGHTS that WIA has destroyed, keeping us from protecting GOD'S GARDEN PARKWAY which WIA has continuously vandalized, protecting our Foundation's Beach House, which was shot up by a WIA appendage, or protecting our \$6.7 million dollar WORLD CLASS TREE ARBOR that WIA maliciously destroyed only a few months ago.

ZIMMERMANN'S DISTORTIONS, LIES, AND THREATS NUMBER 1

"WIA's Board is composed of volunteer citizens who devote a great deal of time to manage the Waterwood community in a fair and efficient manner."

Totally untrue: The Board spends large sums of money harassing us, and doing millions of dollars in damages to SACRED properties including God's Garden Parkway. WIA has NEVER been fair or efficient unless destroying our world class tree arbor in

less than a day while I was in Huntsville and in BLATANT CONTEMPT OF COURT.

ZIMMERMANN'S DISTORTIONS, LIES, AND THREATS NUMBER 2

“My goal is and has been to listen to everyone, consider the viewpoints of all, and serve as a neutral and impartial leader of this association.”

Absolutely false statement. Zimmermann has been our next door neighbor for nearly 23 years. Only once around 15 years or so ago was my father and I invited to his home to peacefully discuss various issues. We were met with extreme hostility and personal insults so left to avoid any further attacks against our persons and our characters.

Back when I felt it was safe to attend the monthly WIA meetings I always tried to give an update on what we were attempting to accomplish in the best interests of the community but Zimmermann would coldly shut me down. I have invited Zimmermann, Board Members and any community members to allow me to take them on tours of our Church and Foundation properties as well as to our Institute for Strategic Biospheric Studies map room so that I could explain about our various wildlife sanctuaries, botanical preserves and archaeological landmarks.

In nearly 23 years the ONLY Board Member that became my best friend in Waterwood was Chuck Bordo who resigned after he was forced to pledge his allegiance to hating me.

By the way, Bordo is a Jew, we have deceased Jews in our “green cemeteries”, the “best man” at our wedding 54 years ago was a

Jew, one of my fellow civil rights marchers is a Jew. We have Jewish members of our Church, One of our best friends in Italy was a Holocaust Survivor. I helped finance a trip to Israel for a Jewish young lady who wanted to help bring peace between Jews, Christians and Arabs and so on.

Once I took Zimmermann for a ride to discuss our Veterans Cemetery sign and other sign matters and Zimmermann told me that the original sign was 'grandfathered' and that I could place 'posted' signs anywhere on our properties where we had had problems with criminal trespass, poaching, thefts and other crimes. I informed WIA twice that I needed to place purple paint on our trees in accordance with State Law and got no response. So we placed the paint on the trees after which I was threatened with 123 years in jail by Zimmermann and his ethically bankrupt Board. John Charlton stalked and harassed our wildlife manager, Mike Zeltner for hours.

ZIMMERMANN'S DISTORTIONS, LIES, AND THREATS NUMBER 3

Zimmermann writes: "Your emails of June 10 crossed the line." How? What line? This is just more Zimmermann intimidation by making his gang believe that there was something "sinister" ? about my non-threatening and honest emails.

ZIMMERMANN'S DISTORTIONS, LIES, AND THREATS NUMBER 4

Zimmermann then tried to drive a wedge between me and our attorney by saying: "...but he will likely be repulsed and embarrassed by your completely unacceptable conduct."

Once again. What “unacceptable conduct”? The unacceptable conduct is Zimmermann’s HATE MAIL to me and his gang and his “leadership” in plotting ways to bankrupt us financially and destroy my life’s work.

ZIMMERMANN’S DISTORTIONS, LIES, AND THREATS NUMBER 5

The last sentence I find to be harassing and threatening, meaning that Zimmermann et al, would obviously, based on his HATE LETTER be prepared to lie to any jury to make them believe that I am some sort of horrible ANTI-SEMITE hater of all Jews when in fact I don’t even hate anyone but certainly am completely disgusted by Zimmermann’s HATE MAIL to me and others in an attempt to paint an ugly picture about the most generous philanthropists in the history of San Jacinto County to maintain the atmosphere of hate that we have had to endure since at least 2004.

THE FINAL LIE IN ZIMMERMANN’S HATE FILLED SLANDEROUS AND LIBELOUT DIATRIBE

“Sincerely” Zimmermann has only been sincere about tormenting my wife and me, and damaging our Church and our Foundation.

OTHER FACTS ABOUT WIA ABUSES, ESPECIALLY OF OUR CHURCH AND CHURCH AND OTHER CONSECRATED PROPERTY

1. OUR CHAPEL OF THE NATIVITY SIGN

Our Chapel sign is decorated with a STAR OF DAVID, CHRISTIAN CROSS and MUSLIN CRESCENT MOON.

Walt Ringler was the leader of a gang of “Christians” that believed that JEWS KILLED JESUS and hated all Jews. He so hated the STAR OF DAVID on our Church sign that he said he was selling out and moving so that he wouldn’t have to see that hideous Jewish symbol, and he did, but not before harassing the hell out of us. When he held a huge street party he blocked the road with a vehicle that had a large sign on it that said something to the effect of: GEORGE RUSSELL: STAY OUT YOU ARE NOT WELCOME. He called me a “Jew Lover”, a statement that I didn’t disagree with as I have embraced members of all faith traditions so long as they operate in an ethical fashion.

2. OUR SUNSET SERVICES

We have had very few Waterwood residents attend any of our Sunset Services. Early on, a couple came to our service and bragged to their friends how wonderful it was and they were immediately SHUNNED just as my wife and I have been since at least since 1998. As they were not invited to anymore Waterwood social activities they sold their house and moved away.

3. WIA's HATRED OF JEWS BECAUSE THEY KILLED JESUS

Until we bought Waterwood Parkway in 2000, Zimmermann had been FORBIDDEN from placing a MENORAH on the parkway along with any other Jewish holiday symbol.

After we bought the parkway, I told Zimmermann that I was disappointed that the Christian dominated WIA Board refused to allow a Menorah on the parkway and asked him to construct one and place it there which did.

4. OUR EASTER SUNRISE VIGIL

Waterwood has always been invited to our annual EASTER SUNRISE VIGIL but I think only residents who are also ostracized have attended.

5. THREATENED WITH ASSAULT FOR INVITING A NEIGHBOR TO CHURCH

After we purchased the properties on Bay Hill Point Drive, I invited our neighbor up the hill to join us at our Sunset Services. The man's son came up to me and threatened me with assault for even issuing the invitation.

6. THE CULT INVESTIGATOR

People in Waterwood called in a cult investigator, telling him that we were running some kind of DEVIL CULT. The investigator was very friendly and said that he loved our Church and that he would spread the word that it was NOT A DEVIL CULT

7. COLDSRING SCHOOLS

Literature was passed out at the elementary school in Coldspring that said that I run a DEVIL CULT and that I capture little boys, teach them perverted sex acts then kill them, roast them and eat them and that I had already eaten three little boys. I'm not sure who it was but I suspected Walt Ringler as the most active and malicious hater of me and our church.

8. GOD'S GARDEN PARKWAY

When we first purchased our 4 lane parkway sections in 2000, WIA and Wia's contractor, "Shorty" worked closely with me to insure that all 130+ species of native plants were protected. Zimmermann, dba WIA, hated the wildflowers and the fact that we owned the parkway so convinced the Commissioner's Court, we believe illegally, and certainly unethically to give WIA control over our privately owned parkway in July of 2009, which we consider to be an ILLEGAL TAKING OF PRIVATE PROPERTY. The county only had an easement, aka right of passage over the pavement and zero rights to destroy native vegetation but WIA controls the courts, the sheriff, the JP, the Constable.

WIA began a campaign of destruction of what we had paid a large sum of money to protect from harm. It was criminal trespass and vandalism pure and simple and of course Zimmermann did nothing to stop the harassment of me or the destruction of native plants.

Of course Zimmermann lied and in a June 14, 2011 lawsuit against me and my wife said that my HANIDCAPPED SENIOR CITIZEN WIFE were interfering with the maintenance of the parkway. Asking WIA to please not destroy rare wildflowers including rare orchids is in no way interfering with so-called "maintenance". MAINTENANCE means maintaining NOT DESTROYING.

The HATE CRIMES against us and our millions of dollars in investments in attempting to protect Waterwood from WIA crimes intensified and our favorite trees and flowers were targeted for destruction, including rare pink bluebonnets that were destroyed right after I asked WIA to please allow them to go to seed.

The harassment, intimidation, trespass, vandalism and thefts of our “posted” signs continued unabated.

Zimmerman, dba WIA sued my wife and me again on July 14, 2014 as one more act of costly intimidation. With WIA’s control of the courts, of course we never had a chance to ever win against WIA.

By January 2016, we had been threatened, harassed, were financially unable to continue attempting to protect ourselves or our rare plants on our parkway and finally caved in when ZIMMERMAN promised EVERLASTING PEACE between WIA and our Church and our Foundation and us.

He made numerous false promises just as he had done over the years. In fact to this very day I cannot recall a single promise to me made by Zimmermann that he ever kept.

On Feb 23, 2017 ZIMMERMANN issued a TERRORISTIC THREAT through the courts in which I was supposed to go to jail for 124 years and pay a \$103,500 fine. The purpose of this threat was in DIRECT VIOLATION OF THE STATE BAR CODE OF ETHICS.

Please keep in mind that Zimmermann lied when he personally told me that I could place “posted” signs anywhere that we had had problems with criminal trespass, vandalism, thefts, poaching etc.

Yet, I informed WIA in writing twice of the need to address the issue and rather than place signs, I placed purple paint stripes in strict accordance with STATE LAW.

Purple paint is NOT A SIGN but Zimmerman et al argued that purple paint IS a sign, which is no more a SIGN than dark clouds are a sign of possible rain, a wedding ring is a sign that the person wearing it is married, a rattlesnake rattling its tail is a sign that you had better step back or perhaps be bitten.

The destruction of native species on the parkway has continued unabated in spite of Zimmermann's promise that WIA would take better care of the native plants than we had from 2000 until 2009 when the CORRUPT COMMISSIONER'S "gave" our PRIVATE PROPERTY to WIA to damage or destroy at its whim.

Zimmermann promised to mark the Longleaf Pines in the median of God's Garden Parkway so that people would be able to identify them with ease while driving past.

In addition, IF PURPLE PAINT is defined by law as a SIGN then Zimmermann had agreed in our formal "agreement" that disapproval for "signs" "SHALL NOT BE UNREASONABLY WITHHELD".

Having given WIA notice twice although ZIMMERMANN LIED TO THE COURT and said that I hadn't, the fact is that disallowing us to PROTECT SACRED CHURCH PROPERTY with purple paint would have been TOTALLY UNREASONABLE.

Another VERY IMPORTANT part of our agreement of 2017 was that WIA or WIA contractors would NOT touch any of our trees unless there WAS A PUBLIC HEALTH OR PUBLIC SAFETY ISSUE.

There were no public health or public safety issues in regard to our \$6.700,000 WORLD CLASS TREE ARBOR that WIA paid to have IRREPARABLY MUTILATED nor any such issue with the regard to SACRED TREES ON CHURCH PROPERTY that were mutilated for ZERO LEGITIMATE REASON.

Even though Zimmerman is no longer the President of WIA, I sense, based on past years when he had to temporarily be off the Board, that he is still advising his successors about how to continue to harass, intimidate, threaten, and DESTROY MY LIFE'S WORK!!!

EMOTIONAL DISTRESS AND PTSD

Zimmermann et al have done everything possible except murder me to place us under great financial duress and serious emotional duress. I feel as if I, especially, have been living in a WAR ZONE, never knowing when I will be stalked, harassed, held hostage, threatened by dirty law enforcement, assaulted, spotlighted at night, shot at, and so on and on and on.

It used to give me great joy to drive down our two sections of Waterwood Parkway to admire the myriad species of wildflowers and other native plants, Now the drive both ways is extremely depressing and distressing as WIA has conducted a relentless war, especially on GOD'S GARDEN PARKWAY, which was owned by our Church and dedicated to GOD'S HOLY CREATION, hoping that WIA would show at least a little respect for creation and cease and desist from further damage and do a better job of protecting nature than we had according to Zimmermann's promise which turned out to be just another bald-faced lie.

Worse still is never knowing when Zimmermann's successors will DESTROY what we have worked our entire lives in order to purchase and protect. The multi-million dollars in damages to what had been a WORLD CLASS TREE ARBOR sent me into such a state of depression that I contemplated suicide for the first time in my life.

I was issued an M-1 rifle in 1963, lived in the jungles of Central America 175 miles from the nearest telephone paid for by the Department of Defense, was commissioned as a Second Lieutenant in 1970 and spent 4 years on active duty as a STRATEGIC COMMUNICATIONS CRYPTO OFFICER, Company Commander and as Adjutant, was among other duties, Secret Documents Custodian.

I never suffered from depression or anxiety until Zimmermann, dba WIA, began a WAR AGAINST OUR CHURCH, AGAINST OUR FOUNDATION AND AGAINST MY WIFE AND ME.

Travis Kitchens was Zimmermann and WIA's partner in crime and did everything in his power, thumping his nose at the Texas Bar Code of Ethics, to destroy our Church, our Foundation, our life savings and my mental health.

For example, Kitchens wrote to our attorney, Hans Barcus: "It appears that Mr. Russell has once again gone off the reservation." I have no idea how to apply this jab to anything I have ever done to Kitchens or Zimmermann.

Kitchens then exposes his TOTAL IGNORANCE of how Jews suffered at the hands of the Nazi regime in Germany between 1933 and 1938.

He writes: "...nothing that Mr. Russell has experienced in his PRIVILEGED LIFE (emphasis mine) comes close to what one human being in Germany suffered at the hands of mass murdering Hitler."

Hitler did NOT MASS MURDER JEWS in Germany period!!

There were 522,000 Jews in Germany in 1933 and as they were persecuted and their lives made miserable just as Zimmerman and Kitchens made our lives miserable, and now Larry Maas, and his "Board" have continued to damage and destroy our properties and continue to make our lives miserable, 304,000 emigrated to friendly countries from 1933 through 1938, leaving 214,000 Jews in Germany.

"Beginning in late 1941, the remaining community was subjected to systematic deportations to ghettos and ultimately, to death camps in Eastern Europe."

"In May 1943, Germany was declared JUDENREIN (clean of Jews) and JUDENFREI: (free of Jews).

"By the end of the war, an estimated 160,000 to 180,000 German Jews had been killed by the Nazi regime and their collaborators."

These killings, which include starvation, took place outside of Germany.

The HOLOCAUST was very real and very terrible and to educate people about the horrors of any and all of the GENOCIDES around the world, we have exhibited photos of famous GENOCIDAL MANIACS which include: Idi Amin, Adolf Hitler, William Westmoreland, Mirabeau B. Lamar, Abraham Lincoln, Janet Reno, George W. Bush and many, many other mass murderers.

HISTORY OF JEWS IN GERMANY FROM 1933 UNTIL KRYSTALNACHT ON NOVEMBER 9, 1938

THE HOLOCAUST: TIMELINE OF JEWISH PERSECUTION

1933

Feb 2: Political demonstrations banned affecting entire population

COMMENT: 100% of my FIRST AMENDMENT rights have been taken away from me with threats of arrest and imprisonment should I protest the maltreat my wife and me and hate crimes against our Church. I fear for my safety should I dare to try to attend a WIA meeting. Zimmermann had a resident thrown in jail without his meds for attempting to record a WIA meeting on my behalf. He felt so threatened by Zimmermann and WIA that he moved away from Waterwood.

Feb 12: Riots in Berlin lead to the death of one COMMUNIST.

Feb 27: Reichstag building set ablaze. "The Nazis are quick to blame the COMMUNISTS."

March 21: "Special Nazi courts are set up to deal with POLITICAL DISSIDENTS."

COMMENT: I was thrown in jail for Criminal Trespass on my own deeded property when the Judge, the DA, and the Sheriff all had copies of my deed before I was thrown in jail and had to endure a five hour trial. Zimmermann threatened me with 124 years in jail for LEGALLY marking trees on our Church and Foundation properties with purple paint in accordance with State Law. The Constable arrested me a second time for criminal trespass on our same deeded property. He stalked me, intimidated my controlled burn staff and obviously works for WIA.

April 1: Jewish shops are boycotted for a single day.

May 6: “The Institute of Sexual Studies in Berlin is destroyed by pro-Nazi students, likely because of its academic interest in homosexuality.”

July 1: “The German government states that “Reich Chancellor Hitler” still belongs to the Catholic Church and has no intention of leaving it.”

July 20: “Nazi government signs Reich concordat with the Vatican.”

July 31: “Approximately 30,000 people are by now interned in Nazi concentration camps.” The targets of the Nazis at this point were COMMUNISTS and political dissidents.

August 25: Germany and a Zionist Organization made an agreement to “...facilitate large-scale emigration of Jews from Germany to Palestine.

COMMENT: Efforts have continued unabated to force us out of Waterwood. In 2004 the billionaires that wanted to create the

third Disney City told me that they were “buying me out” and that “I wouldn’t live in Waterwood any longer.” Subsequently we have suffered continuous abuses in an obvious attempt to get us to sell out and move away.

Oct 24: “Nazis pass a law against “Habitual and Dangerous Criminals” that justifies placing the homeless, beggars, unemployed and alcoholics in concentration camps.” So far nothing targeting Jews to be placed in concentration camps. The objective at this point was to convince them to move to a “friendly” country.

Nov 24: “The new law “...allows for the compulsory castration of ‘hereditary’ criminals.”

1934

Early January: “Youth members are turned loose throughout Germany to intimidate members of CATHOLIC youth groups.”

April: “Germany establishes the People’s Court to deal with enemies of the state...”

COMMENT: I have been victimized as an enemy of the state, aka WIA and have suffered with two false arrests and multiple other abuses. The Sheriff refuses to investigate HATE CRIMES against us including the shooting up of our Foundation’s Beach House and other crimes in which the perp is known.

Our Clovis Paleo archaeological site has been invaded several times and artifacts stolen. The Game Wardens refuse to attempt to have the artifacts returned although they have photos of the perps taken by our cameras.

“Twenty-five Points of the German Religion” are issued in Germany by Professor Ernst Bergmann. It holds that Christ was not a Jew but a Nordic warrior put to death by Jews, and whose death spared the world from Jewish domination; Adolf Hitler is the new messiah, sent to Earth to save the world from Jews.”

1935

April 1: “Jehovah’s Witness organization is banned because they refuse to swear allegiance to the state.”

Nov 15: “The German Churches begin to collaborate with the Nazis by supplying records to the government indicating who is a Christian and who is not; that is who is a Jew.”

COMMENT: Because of our STAR OF DAVID and because The Universal Ethician Church is NOT a Christian Church and I am not a Christian, there has been significant hatred directed against our Church, our botanical preserves, wildlife sanctuaries and against me.

1936

April 15: “Two Jews are murdered during an Arab general strike in Palestine in protest against Jewish immigration.”

(SO FROM 1933 THROUGH 1936 NO JEWS WERE SINGLED OUT UNLESS THEY WERE COMMUNISTS OR DISSIDENTS, HOMOSEXUALS OR HABITUAL CRIMINALS AND NONE APPEAR TO HAVE BEEN MURDERED IN GERMANY BY THE NAZIS)

July 15: Buchenwald concentration camp opens near Weimar to house COMMUNISTS and other targeted groups. It was a forced

or slave labor camp that included Gypsies, Freemasons, the mentally ill, physically disabled and sexual deviants. THERE WAS NEVER A GAS CHAMBER AT BUCHENWALD and most deaths were from overwork and malnutrition. Of course there would have been some Jews in the above referenced targeted groups.

“SS functionary Adolf Eichmann, posing as a journalist, visits Palestine to investigate the feasibility of mass deportations of German Jews to that area.”

1938

June 9: “Nazis destroy the Munich Synagogue. They burn it to the ground.”

COMMENT: There have been thefts, break-ins, two arson fires, tree mutilations and other crimes committed against our Chapel of the Nativity property as well as crimes committed against our Church cemeteries including our Veterans Cemetery. When a suspicious fire broke out on our chapel property, no one bothered to call 911. My wife happened to drive by and called for help. Subsequently SHECO caused a serious fire on our Longleaf Pine Sanctuary. Waterwood VFD was out of business and the fire department that arrived had no idea how to stop a forest fire so Mike Zeltner drove our bulldozer overland two miles and built a fire lane so that the fire could be put out. SHECO fraudulently blamed me for the fire and then me and GOD!!!

July 12: Sachsenhausen concentration camp opened for POLITICAL PRISONERS.

July 23: “Jews in Germany are ordered to apply for identity cards to be shown to police on demand.”

COMMENT: I have been falsely arrested five times, assaulted by Federal Agents for handing out a press release, assaulted by dirty cops, assaulted by dirty Game Wardens and the two Game Wardens in San Jacinto County REFUSE to go after known criminals, lie about the beach house shooting and Melissa Brown has threatened me with jail for interrupting poachers that had set up a camp in one of our wildlife preserves.

July 25: “Father Charles Coughlin calls for the establishment of an American Christian Front to combat Communists and Jews.”

COMMENT: As a non-Christian, at least two Huntsville churches have preached against me, The Chief of Police hates me with such a passion because according to him, I am going to burn in the fires of hell so he openly allowed a gang of druggies to invade our \$600,000 house and refused to do anything about open drug activity from hopped up and dangerous druggies and the meth lab exploded doing at least \$300,000 in uninsured damages. He is a member of an extremist Christian Cult.

Aug 10: “Destruction of the Great Synagogue in Nuremberg.”

Sept 12: “Jews forbidden to attend public cultural events.”

COMMENT: I have been forbidden to join the Waterwood Yacht Club, even watch card games in the WIA offices, participate in the Community Wine Downs, am hated by the members of the Golf and Recreation Association that shot up our Foundation Beach House. Four of our vehicles have been shot at and hit with the projectiles coming from Steve Heide’s property. MY WIFE AND I HAVE NOW BEEN LOCKED OUT OF THE GARBAGE DUMP DESPITE HAVING PAID WIA MANY THOUSANDS OF DOLLARS IN HOA DUES.

November 9-10

KRISTALLNACHT (Night of the Broken Glass) occurs across Germany and Austria. Ninety-one Jews are killed; others are beaten. Thirty thousand male Jews are sent to concentration camps, though most will be released in a few weeks.

“Adolf Hitler tells Minister of Justice Hans Frank that he has come to fulfill the curse imposed by the Jews themselves in the NEW TESTAMENT: “His (Jesus’s) blood be upon us and upon our children.”

It was at this point that Hitler began the horrors leading up to the HOLOCAUST.

1939

Jan 1: Even the mal-treatment of Jews in Nazi Germany had not resulted in wholesale slaughters, gassings etc. but at Buchenwald the Commander “selects five men and has them whipped to the melody played by the inmate orchestra.”

Dec 8: Six Jews and 25 non-Jewish Poles were shot in Poland – NOT GERMANY

Dec 27: “106 NON-JEWISH POLES are murdered in Warsaw, Poland – NOT GERMANY

1940

Jan 12: The Gestapo and SS men shoot and kill 300 inmates of a Polish insane asylum – NOT GERMANY

Spring 1940: “the first deportations of German Gypsies begin, from Germany.” It was Gypsies – NOT Jews that were deported at this time.

June 14: “The first deportation to Auschwitz carried 728 Polish political prisoners, including teachers, priests and other NON-JEWISH Poles.”

November 11: “Fifty-five NON-JEWISH Polish intellectuals are murdered at Dachau.”

November 25: “The ship Patria, carrying 2,000 Jewish immigrants, is accidentally sunk by the radical Jewish group Hagana. About 250 Jews on board are killed.”

1940: Other important events: “Six ‘euthanasia’ centers are set up in Germany to murder Jews, the mentally ill, the elderly, the physically ill, and the handicapped.”

COMMENT: As far as I have been able to determine this is the first mention of murdering Jews along with other “undesirables”, according to the Nazi regime. (This was TWO YEARS after 1938)

1941

Sept 3: “First gassing tests in Auschwitz using Zyklon-B. The victims were Soviet prisoners of war and NON-JEWISH Polish inmates.”

Sept 23: More “gassing tests are conducted at Auschwitz.” Apparently the tests were conducted on prisoners of war.

Oct 14: “German Jews are deported to the Lodz Ghetto.”

December: “The Jesuit journal Civiltà Cattolica, published in Rome under strict Vatican supervision, reminds Catholics that the Jews are supposedly those primarily responsible for murdering God and that the Jews repeat this crime by means of ritual murder in every generation.”

Dec 11: “The United States declares war on Germany and Italy which provides hope to Europe’s Jews.”

December-January 1942: “Six hundred Soviet prisoners of war are murdered in gas-chamber experiment at Auschwitz.”

1942

Feb 15: “THE FIRST MASS GASSINGS OF JEWS AT THE AUSCHWITZ DEATH CAMP BEGIN.”

COMMENT: Auschwitz is in Poland and NOT Germany. So far I have found no evidence of the mass killing of Jews in Germany, keeping in mind that 1942 is 9 years after 1933 and 6 years after 1938 – the years during which WIA has treated me “like a Jew in Nazi Germany” and still continues to treat me like a Jew in Nazi Germany BEFORE the Holocaust began. They were indeed harassed and mistreated but mostly encouraged to emigrate.

March 3: “Belgian Jews are drafted for forced labor.”

April 3: “This day’s deportations from Augsburg, Germany, empty the town of Jews...”

May 4: “First selection for gassing performed at Auschwitz. These were the weak, sick and ‘unfit’ prisoners.”

June 1: “Treblinka extermination camp opened. Mass exterminations by gassing were started on July 23, 1942”

COMMENT: So far, I have found no record of the gassing of Jews in Germany.

June 6: “Adolf Eichmann insists via a telegram sent to Gestapo officials that residents of a mental institution must be included in a planned mass deportation of Jews from Coblenz, Germany to Poland.”

June 13: “British Ambassador to the Vatican...observes about Pope Pius XII, that his ‘moral leadership is not assured by the unapplied recital of the Commandments.’”

COMMENT: Up to this point it appears that it was Christians behind the mass murders of Jews and others. I am NOT a Christian and have always promoted peace between Jews, Christians and Muslims.

Other 1942 Events: “A gas chamber (probably never used) and a crematorium are installed at the Dachau concentration camp.”

COMMENT: The gas chamber at Dachau was the only gas chamber in Germany that I can find evidence of and it was “probably never used.” Thus the mass murders of Jews for the most part took place outside of Germany.

1943

COMMENT: By 1943 it appears that all Jews had either emigrated to friendly countries or been deported to other countries controlled by the Nazis.

1944

Aug 4: Anne Frank's family is arrested by the Gestapo in Amsterdam.

COMMENT: We produced an educational film: ANNE FRANK and THE HOLOCAUST. Zimmermann was given a copy and never acknowledged the gift of that film or the other one we produced: THE HOLOCAUST: A HISTORY.

1945

April 29: "American troops liberate Dachau."

April 30: "Hitler commits suicide."
